Glewstone safety – 30mph speed signs painted on the road zone area.

It was agreed by the members present that we instruct Balfour Beatty to proceed with the work based on there revised quotation of £1750.00 plus vat.

Fly tipping of tyres in the stream A4137 Dry Arch area.

The Clerk has discussed this with our Ward Councillor for help and further advice as Balfour Beatty have declined to collect them on the grounds that as they are in a stream and is a central government environmental matter!

A40 group action from Parish Councils. Our Chairman reported that this is ongoing with the intention to involve Highways.

Church toilet - planning insistence on relocation – the meeting expressed their surprise and disappointment on the recent decision made by Herefordshire Council.

222006 and 222007 Lower Daffaluke holiday home conversions and associated matters. The meeting objected to this proposal on the same grounds as before being concerns for safety of the increased traffic and service vehicles that will result on this very narrow lane.

222104 Glewstone Boat extensions and alterations.

The meeting objected to the proposals submitted with safety concerns for the increased traffic leading from the main dual carriageway and concerns that the public right of way would become blocked due to build work and longer-term access for walkers.
