# 2. DECLARATIONS OF INTEREST

N Roper declared an interest in planning applications 222394 and 222569 as he farmed this land and the declaration recorded in the register.

N Roper left the meeting room when these planning applications were discussed, and a resolution made.

## 3. OPEN DISCUSSION FOR THE PUBLIC

The Chairman invited the residents attending to make their comments regarding the planning applications

222394 land west of Chapel Cottage proposed 5 new dwellings

222569 land at Glewstone proposed 2 new dwellings

The comments were noted by the Clerk and following instructions from the Council members reported the matters to Herefordshire Council planning under reference

845744 for application 222569

845742 for application 222394

The comments / concerns were regarding

Water supply – already poor for the existing housing with no apparent plans for future improvement.

Concerns regarding waste drainage and land contamination.

Land is class 1 agricultural land in the AONB and should remain so – the proposal with be most visible on the landscape.

No supporting infrastructure such as shops / bus services which will therefore mean increased communing vehicles and service transport.

There is already a marked increase in commuter traffic in Glewstone as a result of the increase in housing development from nearby villages.

For application 222569 there was the additional concern of safety to children who need to wait for the school bus in this area / crossroad.

The Chairman thanked the residents for their comments and urged them to also write individually to planning with their concerns.

The Chairman then closed the open discussion for the public session and the formal Council meeting continued.

# 5. ACTION POINTS FROM THE MINUTES

Tyres – flytipping – with thanks to the intervention of our Ward Councillor Balfour Beatty have now further inspected and agreed the removal! However, a landowner frustrated by the delay of action has now taken them from the stream.

It was agreed that N Roper would make contact and review if further actions were required.
