## **1 OPEN DISCUSSION FOR THE PUBLIC**

The officer described the possible various actions that residents could carry out but highlighted that sometimes apparent speed of a vehicle could be misleading.

The residents and M McLelland raised the matter of a possible community notice board at Glewstone. Discussion brought attention to considerations of land site the actual board management and sufficient long-term interest compared to apps and other communication.
