3 ACTION POINTS FROM THE MINUTES

Flooding related issues – reference council member inspections and notes circulated. A parish inspection was recently made by A Williams R Mutlow and M Wigmore to identify the main flood / water related problem areas and possible causes resulting from the recent heavy weather rainfalls.

These have been highlighted in the report circulated to all members being:

Boat Lane

Old school / Daffaluke Road

Campsite - lane from the church

Road area near the church

Road off Hereford road to the church

Following discussion it was agreed to arrange a site meeting with our newly appointed Locality Steward, Chairman and pc member to further identify these issues and actions that can be undertaken by Balfour Beatty.

From this further smaller works can be identified for lengthsman work. The meeting agreed that 3 separate quotations should be made with an agreed timescale of such works.

To maintain future control members will carry out inspections of sensitive areas seasonal / weather related.

Boat Lane is a particular problem being one of the first to flood and one of the last to clear in the county (some 32 issues). The Clerk has discussed this with Balfour Beatty and it has been confirmed that inspection and the ditch clearance will be attended by them.

It was suggested that a water depth line and flood warning sign could also be considered to further warn motorists – discussion with locality steward.

The Ward Councillor apologised to leave the meeting for other matters.
